Motion: Compensate person with \$100 Pre-paid Visa card for alerting township (who received fraud check in ND) for contacting the township, saving over \$10,000. Motion by Saucier, 2<sup>nd</sup> by Sholty, Ayes: 4, Nays: 0, Motion Carried.

Motion: Accept to Police Contract. Motion by Bergstrom, 2<sup>nd</sup> by Sholty, Ayes: 4, Nays: 0, Motion Carried.
