#### HIGHLIGHTS

A report of a felonious assault was investigated on November 13<sup>th</sup> in the 20000 block of West Howard City-Edmore Road. A 21-year-old woman from Cedar Springs and a 28-year-old woman from White Cloud stated a man they were familiar with pointed a gun at them and threatened to shoot them. The man, a 22-year-old from Morley, was interviewed. The investigation is being reviewed by the prosecutor's office.
