7:05 Open public hearing on retail commercial proposal, Dollar General, on M46. Parcel # 017-014-015-22

- Ryan Mcehill from ENG and Pete Oleszczuk from WestWind present the rezoning request.
- Ryan Mcehill gives an overview of project scope and design.
 - Well and Septic permits have been approved.
 - MDOT has approved with the exception of driveway location - pending approval based on culvert location / design at M46.
 - Easement on the east side of the parcel to be abandoned and deeded to the adjoining property owner.
- Pete Oleszczuk: Request to rezone narrow strip of land at north side of parcel from R1 to Highway to match majority of parcel and to avoid any future issues.
- Pete Oleszczuk: Request for reduction in zoning required number of parking spaces by 10. Zoning requires 43 spaces, and the request reduces to 33 spaces. Reduction is based on established operational needs of numerous other similarly sized Dollar Generals. There is space reserved for the additional 10 spaces should they be needed in the future.
- Ed Valacus - Owner of adjoining parcel to the east concerned about the cost of surveying required to abandon existing easement and deed the land to him.
 - Pete Oleszczuk responded that West Wind would bear the cost of any surveying / recording / etc, needed to abandon the easement.
- Jerry Poprowski comments the use does fit with the Master Plan.
- Chris Hammer - Owner of the adjoining parcel to the west is in agreement with the rezoning request.
- General discussion of the reason for the reduction in parking spaces and potential impact on M46 traffic.
 - Agreement that traffic issues / design / considerations are the purview of MDOT on a state highway and not the PC.
