Supervisor Kindel called the regular Meeting of the Board to order at 7:00 pm., Pledge of Allegiance was given.

MEMBERS PRESENT: Supervisor Kindel, Clerk Sholty, Treasurer Stedman and Trustee Saucier.

CONSENT AGENDA: Deputy Fox presented the Police Report and Mark Stevens presented the Zoning Report

Motion: Approve consent agenda consisting of the April 8, Regular Meeting of the Board Minutes, Police Report, Fire Report, Zoning, Report, Planning Report, Treasurer's Report, Library Reports and the Township's Monthly Bills. Motion by Saucier, 2nd by Stedman, Ayes: 4, Nays: 0, Motion Carried.

OLD BUSINESS:

Discussion to streamline process of zoning violation issues in the township with Montcalm County Sheriff's Department.

Audit is still being processed. Settlement was received from the County Treasurer's Office.

Planning Commission recommended rezoning a portion of 46 from Highway/R2 to Industrial.

Motion: Accept Planning Commission's recommendation, and rezone portion of M46 from Highway/R2 to Industrial. Motion by Sholty, 2nd by Saucier, Ayes: 4, Nays: 0, Motion Carried.

NEW BUSINESS:

Discussion regarding making all Class-A roads Commercial/Industrial. Should be topic of discussion in MasterPlan Meetings.

New Trustee needed to fill Jason Lund's vacancy.

Motion: Appoint Robert (Bob) Bergstrom as Township Trustee. Motion by Sholty, 2nd by Saucier, Ayes: 4, Nays:0, Motion Carried.

New Township flag pole needed due to vandalism. Motion: Purchase new flagpole and flag for township. Motion by Stedman, 2nd by Sholty, Ayes: 4, Nays: 0, Motion Carried.

Vandalism on the rise in the Village of Howard City. Camera installation discussed.

Motion: Purchase hard-wire camera with 3-year protection service. Motion by Saucier, 2nd by Sholty, Ayes: 4, Nays: 0

Township will receive Rescue Recovery Grant Money as a non-entitlement unit (less than 50,000 population.) At this point unsure of how much money and how it must be spent. More information to come.

Current Bills are in the House/Senate regarding possible election changes.
